

# YMCA CHILD CARE

2020-2021

The Ventura Family YMCA is providing child care to support both distance and hybrid in-person learning schedules.

WHEN: Begins Monday, November 30th.

**WHERE:** On-site care is provided at Loma Vista, Elmhurst, and Poinsettia Elementary Schools. The YMCA can accommodate students from any school but are unable to provide transportation.

**COVID-19 Information:** The YMCA will be providing care in stable cohorts of no more than 14 children. Each cohort will be in their own space and will not comingle with other groups. Children will be health screened each day prior to care.



# YMCA CHILD CARE 2020—2021

### Payment/Cancellation Policies:

- 1. Payments will be made EFT or credit card only and scheduled for the Saturday before each week of care starting Saturday, November 28th. Check payments will only be received for full payment at time of registration.
- 2. A 30 day <u>written</u> notice is required to cancel. After 30 days, no credits or refunds are given. A 30 day <u>written</u> notice is required to make any changes to your care. An additional \$15 change fee is required for each session that is changed.
- 3. Before attending the program, all participants are required to register online at least one week in advance before attending care and have their ePACT health information completed. Spaces are limited due to our licensing standards and Covid policies on small cohorts, and are filled on a first come first serve basis. In the event that all spaces are filled, a waiting list will be created according to registration submission.
- 4. Fees are based on enrollment rather than attendance, and fees are not pro-rated if your child is unable to attend for any reason; illness, vacation, doctor appointments, etc. In order to maintain consistency within the program and keep with all state mandated Covid policies, the YMCA child care program is not able to accommodate rotating schedules. All program participants must be continuously enrolled in the program.
- 5. Fees include all break weeks and non school days, excluding the following holidays: Christmas, New Year's and Memorial Day.
